The application for nominees opened on June 30 and will remain open through School Year 2024-2025.

INDIANA RECIPIENTS OF THE 2023 USDA FARM TO SCHOOL GRANT



INDIANA DEPARTMENT OF HEALTH

The Division of Nutrition and Physical Activity (DNPA) within the IDOH will complete a range of activities from July 2023-2025, building upon the successful farm to school expansion over the last four years and responding to the changing landscape as the nation emerges from the COVID-19 pandemic. First, the DNPA will host 20 to 40 community-centered listening sessions to receive feedback about the success, challenges, and visions of the farm to school effort in IN, driving the formation of a strategic priority document to support schools in achieving their farm to school goals. Next, the DNPA will identify 10-20 local educational agencies (LEAs) participating in the Local Food for Schools (LFS) program to receive funding for the implementation of additional farm to school programming. Lastly, the DNPA will hire a Farm to School Value Chain Professional (FSVCP) to support the local procurement of produce in school markets statewide. Working with the Northwest IN Food Council, the FSVCP will join the IN Value Chain Network.

WILD PANSY FARMS

Wild Pansy Farm will canvass an 18-county region to identify five partners for a future farm-to-school implementation grant. They will conduct due diligence research and taste tests to prepare large batches of soup made from farm-raised produce, for distribution to schools. They will use the Turnkey Action Planning Grant to finance travel and salary associated with these activities and create a written plan to execute in 2024.

NWI FOOD COUNCIL

Students and families that are served by the School City of East Chicago (SCEC) have a high demonstrated need for improved food access and nutrition literacy. Community members in East Chicago are particularly vulnerable, as demonstrated by the Social Vulnerability Index, food insecurity data, and the Food Environment Atlas. The NWI Food Council and SCEC leadership will work to address this need by developing an action plan for farm to school initiatives in partnership with Purdue Extension, New Venture Advisors, and the East Chicago community. This action plan will focus specifically on the two SCEC elementary schools of William McKinley and Benjamin Harrison, who are eager to engage with farm to school activities and expand opportunities for student engagement with local food and farms. The action planning process will build on long standing relationships between grant partners, while also cultivating opportunities for new collaborations and meaningful community engagement.
